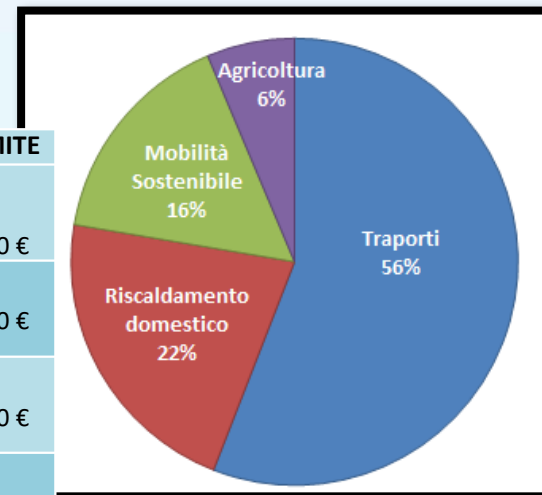

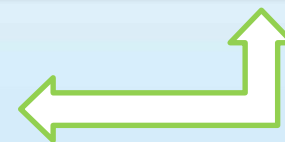

CLEAN AIR PROTOCOL

PNCIA - National air pollution control program FUND 2,3 bilions oh € period 2023-2035

Establishment of a fund for the implementation of the National Air Pollution Control Program, introduced by the Budget Law 2022 in the MITE budget estimate. This fund has an allocation of €2.3 billion in the period from 2023 to 2035, to be used in:

- new air quality agreements
- other air quality actions in the Po Valley Basin.

CLEAN AIR PROTOCOL

PNCIA - National air pollution control program FUND 2,3 bilions oh € period 2023-2035

State-region working group to select the order of priority of interventions in order to direct incentives to the most problematic sectors. The first sector on which to intervene is agriculture with funding aimed at encouraging the replacement of agricultural equipment, the covering of wastewater storage tanks, the use of advanced means of fertilization, the emergence of chains of valorization of agricultural residues in order to avoid their burning in the open

OTHER INITIATIVES



Agreements MITE-Regions

As of 2017, 8 program agreements have been signed with Regions for a total of 11 Regions involved (Po Valley Basin Regions, Campania, Lazio, Liguria, Puglia, Sicily, Tuscany and Umbria for a total of 40 million euros). In the recent period, additional resources of 280 million euros (years 2021-2028) have been made available to the Regions for all Regions outside the Po Valley Basin

Turin protocol signed on 4 June 2019

Air quality action plan

On September 23, 2021, the Council of Ministers signed the Understanding to extend the Turin Protocol until 2023, with a mandate to revise it.

New activities:

Citizen Communication (biomass use, air quality awareness).

New decree law being approved

New Agreement MITE-AIEL-Regions

Introduce new and more challenging initiatives aimed at resolving all the issues of biomass combustion in the civil sector that have slowed the process of improving air quality

- Strengthen training courses for installers and maintainers
- Citizen communication campaign
- Preparation of guidelines for the regions
- Quality of fuels
- Manufacturers' Commitments
- Modification of the decree on the certification of appliances

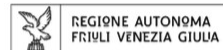
